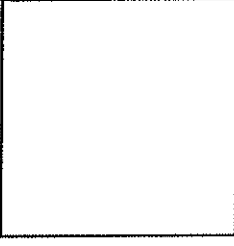


BELIZEAN NATIONALITY ACT 1981 SECTION 4 AND 5

Application for Affirmation as a Citizen of BELIZE by virtue of descent or marriage.

(1) The following must accompany applications:

- (a) Birth Certificate of subject which clearly identifies parents
- (b) Birth Certificate, Passport or other document establishing Belizean Nationality of the parent/grandparent/husband through whom the claim is being made.
- (c) Marriage Certificate where applicable
- (d) Declaration overleaf affirming the relationship and witnessed by a Justice of the Peace (\$1.50 in stamps must be affixed)
- (e) Three (3) photos
- (f) Forty dollars (~~\$40.00~~) fee **\$110.00**
- (g) Renunciation of present nationality

N.B. Please submit original and photocopies of documents (a), (b) & (c)
